PETITIONS AND COMMUNICATIONS

DOWNTOWN DEVELOPMENT AUTHORITY REQUESTS PERMISSION FOR SIGN REPLACEMENT AND BANNER SIGNS FOR THE MASONIC HALL CORNER AT 23715 FARMINGTON ROAD. City Administration advised that both the Downtown Development Authority Board and the Mason's Board of Directors have approved a new sign to replace the ground sign on the Masonic Plaza and the addition of temporary fundraising signs. City Administration advised that the proposed ground sign will be more appropriate for the area and the temporary banners will provide more professional advertising of fundraising events for the Masons.

Ms. Judy Downey, Executive Director of the Downtown Development Authority, was present to answer questions. In response to a question, Director Downey indicated that the permanent sign would not be covered by temporary signs at any time and the temporary banners would be used only by the Masons and would be displayed for varying lengths of time depending on the events, but no longer than 4 days.

CONSIDERATION TO APPROVE RESOLUTION CALLING FOR THE NOVEMBER 6, 2001 ELECTION REGARDING SEWER IMPROVEMENT

PROJECT. City administration advised that the City's sewage disposal system requires rehabilitation at an estimated cost of \$2.5 million. The City estimates that \$1.8 million will need to be borrowed after contributions from the Water and Sewer Fund and the Oakland County Water Infrastructure Fund. City Administration recommended City Council adopt a resolution calling an election and approving the proposed ballot language.

CONSIDERATION TO INTRODUCE ORDINANCE NO. C-686-2001 TO AMEND CHAPTER 28, SECTION 28-90 OF THE CITY CODE, TO AUTHORIZE DIRECT BILLING FOR THE COST OF SNOW REMOVAL FROM SIDEWALKS. City Administration advised that an ordinance amendment is needed allowing the City to immediately invoice property owners for cost of snow, ice and obstruction removal from City sidewalks.

City Manager Lauhoff added that the proposed direct billing is in addition to the violation citations and fines issued through court process.

In response to a question from Council, City Manager Lauhoff indicated that the procedure that is followed is to allow property owners 24 hours to remove obstructions, thereafter a violation citation is issued followed by the City's removal of the obstruction. He also stated that property owners are alerted each year regarding the City's requirement to keep sidewalks clear.
