CONSIDERATION TO APPROVE M.K.A., INC. FOR CONSTRUCTION

MANAGEMENT OF CIVIC THEATRE RENOVATIONS, PHASE II. Administration
advised Council that Phase I of the Civic Theatre renovations had been completed and

that Phase II will include renovation and expansion of the second floor lobby area, updated and improved second floor restrooms, a lift for handicap patrons, and plumbing, electrical, and HVAC upgrades. Administration recommended that Council continue the construction management agreement with M.K.A., Inc. based on their performance in the Phase I renovations of the theatre.

Mr. Clark, President of M.K.A., Inc. was present to answer questions from Council.

Discussion followed regarding green areas at the theatre, lighting in the restrooms, and Theatre operations.

Administration recommended Council approval of a resolution establishing a public employee health care fund under the authority of P.A. 149 and approval of an investment policy for the fund.
