### **APPROVAL OF AGENDA**

### **MINUTES OF PREVIOUS MEETING**

<u>12-05-266</u> MOTION by Wiggins, seconded by Knol, to approve the regular meeting minutes of November 21, 2005 as amended, changing the name to Wiggins as the Councilmember who seconded Motion No. 11-05-262. MOTION CARRIED UNANIMOUSLY.

# FARMINGTON EMPLOYEES' RETIREMENT SYSTEM ANNUAL EMPLOYER CONTRIBUTION CERTIFICATION RESOLUTION

Administration advised that the Retirement System Board of Trustees received an actuarial valuation report for fiscal year ending June 30, 2005; and certified the contribution to the Retirement System for the 2006-07 fiscal year.

<u>12-05-267</u> MOTION by Buck, seconded by Wiggins, to receive and file the Farmington Employee's Retirement System Board of Trustees' certification of the required annual contribution to the Farmington Employees' Retirement System for the 2006-07 fiscal year to be \$421,113. MOTION CARRIED UNANIMOUSLY.

Mayor McShane asked regarding the losses experienced by the Retirement System over the last few years and how the Retirement Board is addressing them.

Clerk/Treasurer Cantrell responded that the Board has consistently addressed losses, but noted that those losses were in line with the market across the board. She advised that it has been determined by the Board that the System has done as well or better than other Pension Systems in the State. She noted that the Board has adopted a "smoothing

approach" whereby gains or losses are smoothed over a four-year period and as a result the System is still continuing to pick up losses from the early 2000 years. She advised that this method avoids huge fluctuations in the employer contribution rate. She noted that entering 2000 the System was significantly overfunded. She stated that the System is still funded at just over 100%. She advised that the 13-14% employer contribution rate is that rate normally expected to fund the System.

Councilmember Knol asked whether the ratio of active versus retiree is forecasted out ten years and how much the City would contribute versus benefit payments. Cantrell responded that forecasted ratios are folded into the assumptions and if the System is funded correctly they should not be a significant factor.

#### CONSIDERATION OF REAPPOINTMENT TO BOARD OF CANVASSERS

<u>12-05-268</u> MOTION by Wiggins, seconded by Sutherland, to reappoint Eleanor Peterson and Margaret Yagerlener to four-year terms on the Board of Canvassers, expiring December 31, 2009. MOTION CARRIED UNANIMOUSLY.

# CONSIDERATION TO APPROVE MUSICAL PERFORMANCE CONTRACT WITH WOODLAND TRIO

Administration advised that members of the community have planned a fundraising event at the Governor Warner Museum. Administration further advised that the event, a *Classical Brunch at the Governor Warner Museum*, would be held on Saturday, June 3, 2006. Administration advised that the event committee is seeking to contract with the Woodland Trio, a group affiliated with the Detroit Symphony Orchestra, to provide the entertainment at a cost of \$1200.

Mayor McShane advised that the event would be privately funded.

Councilmember Buck confirmed with Administration that the \$1200 is seed money that would be recovered through ticket sales and sponsorships.

Mayor McShane stated that the Woodland Trio would be playing in the gazebo from 1:00 – 5:00 p.m. on June 3, 2006. She noted that there is a proposal for two additional events on July 23<sup>rd</sup> and September 10<sup>th</sup> with the same format of classical music with a brunch.
