# CONSIDERATION TO ADOPT RESOLUTION TO AMEND INDUSTRIAL WASTE CONTROL CHARGES

Responding to a question from Councilmember Wiggins, Pastue advised there are currently no businesses that would be affected by this proposed rate change.

In response to a question from Councilmember Buck, Pastue confirmed the rate change is based on increased rates from the Detroit Water and Sewer Department (DWSD).

Treasurer Weber clarified there are two separate charges covered by the proposed amendment to the City Fee Schedule: Industrial Waste Control (IWC) and Industrial Surcharge rates. He advised the IWC charge would affect

residents depending on the size of their meter. He confirmed there are no businesses under which the Industrial Surcharge rate would apply.

Responding to a question from Councilmember Wright, Pastue stated the City has advised residents of the change in water and sewer rates through local publications. He further stated information would be provided in the first quarterly billing affected by the change.

#### **GRAND RIVER STREETSCAPE PROJECT – CHANGE ORDER #1**

RESOLUTION 07-09-161 MOTION by Wiggins, seconded by Buck, to approve Grand River Streetscape Project Change Order #1 to increase the overall contract amount by \$227,427.78 based on the following: increase Streetscape cost by \$78,125.02; increase to include water main replacement by \$141,456.90 with funds coming from the Water and Sewer Fund; and increase to include State Street/Farmington Road crosswalk by \$7,845.86 with funds coming from the Major Street Fund.

#### **PUBLIC COMMENT**

Ken Murray, 21564 Chestnut, requested clarification concerning an ordinance under consideration by the City of Farmington Hills to allow carrying a concealed weapon in public parks.

Public Safety Director Nebus responded the City of Farmington Hills is in the process of making the ordinance change in order to comply with State Law that allows anyone over age 18 to carry a concealed weapon in public.

Brian Golden, 33414 Oakland, thanked Council for allowing the Historical booth to be set up on City Hall property during Founders Festival. He discussed the success of the booth, Historical tours and activities at the Warner Mansion during the festival. He expressed appreciation to Council for their support of all these activities.

#### **COUNCIL COMMENT**

Wiggins questioned whether the vendor selling glo-sticks during the Founders Festival was authorized by the Downtown Development Authority (DDA).

Wiggins announced the annual Duck Race, fundraiser for the Farmington/Farmington Hills Foundation for Youth and Families, scheduled for August 15<sup>th</sup> at 3:00 p.m.

Buck thanked Mr. Golden for his comments and developing a wonderful program promoting Farmington/Farmington Hills history.

Buck congratulated the DDA on the success of the Founders Festival.

Buck requested placing SMART Transportation Service on an upcoming agenda. He would like an evaluation regarding the success of this program and an exploration of possible alternatives to that service.

Buck requested Council make reappointments of Boards and Commissions members prior to expiration of their terms.

Pastue stated the City makes every effort to address reappointments well in advance of expiration dates, but acknowledged a couple of oversights recently.

Wright inquired regarding a fire hydrant at Cass and Oakland Streets that is surrounded by orange cones.

Director Gushman indicated the hydrant was found not to be functioning properly during a recent fire response by Public Safety. He stated his department is waiting till after the Founders Festival to make the repairs.

Responding to a further question from Wright, Director Gushman indicated every Fall the hydrants are pumped down to ensure there is no residual water in the barrel of the hydrants so they don't freeze and split. He stated it would not be feasible to turn on every hydrant in the City every year to ensure they are all functioning.

Wright commented the modifications made to the Festival were very effective. He noted the positive changes to the children's activities further reinforced Farmington is a family oriented community.

Knol thanked everyone involved in the Founders Festival and specifically cited a number of individuals and departments who contributed to its success. She discussed the importance of the Festival to the community.
