# 5. Presentation on DDA Finance and Budget by Chris Weber, City of Farmington Director of Finance and Administration

Overview of DDA funding sources – TIF, PSD, 2 MIL Levy, Events/Other TIF Revenue – coming from other tax entities (City, Roads, Library, Oakland County) to do projects in the Downtown. Everyone will share in the increased value of taxes giving 100% of increase to the DDA- IE new taxes captured after establishment in 1986 would go to DDA. 2 Mil levy was added to anticipate residential development with anticipated maintenance cost increase.
